**HOLY TRINITY CATHOLIC SCHOOL  
PARENT-SCHOOL CONTRACT  
2009-2010 SCHOOL YEAR**

This contract between the **Parent(s)** of one or more Holy Trinity students and **Holy Trinity Catholic School** stipulates the commitments required of all Holy Trinity families. Holy Trinity is a pro-active learning environment and requires parent participation. Therefore, all Holy Trinity students are required to have an adult, preferably a parent, represent the family at all functions and endeavors listed.

**I. Holy Trinity Catholic School**

- A. The school commitment contract must be signed by a parent or guardian each school year and is part of the registration requirement.
- B. All financial obligations for the 2009-2010 school year must be met by the designated pre-registration date in order for a student to pre-register for the 2009-2010 school year, except of course, tuition that comes due after the pre-registration date.
- C. The undersigned parent(s) agree that the timely payment of tuition is a contractual duty on the part of the family of each student in Holy Trinity Catholic School and agree that they will make such payments by the designated due dates.

**II. Holy Trinity Catholic Church**

- A. Holy Trinity Catholic Church is a financial supporter of our school. Registered Parishioners, who have been active, Stewardship contributing members of the parish during 2008, are assessed a lower tuition rate because of their contributions of Time, Talent, and Treasure to the parish. Nonparishioners and those families who claim parish membership but are not Stewardship contributing members of the parish are assessed higher tuition rates.

**III. Annual Fund Raiser**

- A. Holy Trinity Catholic School obtains substantial funds each year through its various fund-raising activities, thereby allowing the School to charge lower tuition than would otherwise be required. Accordingly, every family is expected to participate in the School's fund-raising activities.
- B. Every family is expected to participate in the designated Fund Raiser. A family may choose to be relieved of the expectation to participate in the Fund Raiser by paying a fee to the School of \$50 per student in the School, and any family who fails to participate in the fund raiser will be charged this \$50 per student fee.

**IV. Tardies and Absences**

- A. Attendance at school -- every class, every day to the extent possible -- is necessary to ensure the proper learning environment. The School has specific policies on tardies and absences, as described in the Parent-Student Handbook and in a handout given out in the communication packet during the first week of school. Each family agrees to read, understand, and abide by these policies.

**V. Attendance at PTO Meetings**

- A. Early in the school year, there will be a Back to School Night for every class in the school plus approximately 4 meetings of the Parent-Teacher Organization. Information about the School and our children's learning environment is disseminated during these meetings. Every family is expected to have an adult representative, preferably a parent in attendance at these meetings.
- B. Families who miss more than one of the PTO meetings will be charged an additional fee of \$10 per meeting missed.

**VI. Parent Participation Hours**

- A. All families are expected to contribute their Time and Talent to Holy Trinity Catholic School. Such efforts help keep tuition lower than it otherwise would be, while also adding to the learning environment for our students and providing appropriate role modeling for the students. The opportunities for service to the School are numerous and varied.
- B. Each family is expected to contribute a minimum of 20 hours per school year. The School will charge an additional fee of \$10 per hour for each hour of service less than 20 hours that is missed by a family.
